Special Presentation: Perspectives on Social Cohesion (Day 1)




Setting the stage for ICCS 2022 plenaries and breakouts, the Special Presentation will address how differences in culture, beliefs and value systems, alongside the many identities we have as individuals and groups, impact social cohesion. Perspectives from Southeast Asia and globally will be aired in the discussion.

1st Plenary: How Faith Can Bridge Divides (Day 1)



This plenary seeks to critically examine the reasons for the rise and endurance of social polarisation due to ideological or religious beliefs. With a stronger understanding of these divides and the reasons behind them, we hope that some of the lessons gleaned can be applied to foster inter-religious peace and harmony in plural societies both across the region and well beyond. Specific lessons from faith traditions will be shared.


2nd Plenary: How Diversity Can Be Harnessed for the Common Good (Day 2)



This plenary will seek to address the tools and concepts to understand a world marked by super-diversity, that is the existence of highly complex and heterogeneous societies. It will raise questions about how to talk about identities and with people of different and overlapping identities, as well as to appreciate the complex but important role the intersectionality of identities plays in forging social cohesion. It will discuss the way that our belonging and identity overlap across issues such as gender, class, race, nationality, religious and worldview, both as individuals and as groups.

Only by understanding complex interconnections and interdependencies between individuals and social systems can we increase our social capital and create opportunities for individuals in society to form deep bonds across differences, towards a common good.

3rd Plenary: How Technology Can Be Leveraged to Foster Mutual Trust (Day 2)



This plenary will ask, given that we know digital platforms can create echo chambers and be used for divisive ends, how can we employ them to promote social cohesion? People's identities are part of this, including their religious identities, but practical examples of how cohesion is built online and with technologies such as social media is central to this plenary. Looking from different global angles and focusing on areas such as community-building, preventing and countering violent extremism, and mapping global peacebuilding, this session will seek to show how online platforms may be beacons of cohesion and hope, rather than division and hatred.

Breakout Session 1 (Day 2)

Delegates will choose one to attend

Faith 1: Religion, Resilience & Cohesion (International Perspective)

This breakout session has an interest in different faith-based strategies in building resilience against divisive, even extremist, religious narratives within communities, and how religious leaders and communities can build wider resilience beyond their tradition across societies. It will focus on international contexts. Examples of good practice and ways of speaking into such situations may be discussed.

Identity 1: Languages, Identity & Belonging

This breakout group examines how languages shape our perceptions of self and other, and our understanding of identities. Identity and language are key in building one's sense of belonging, especially for minority groups. This breakout group can explore how the limits in languages, the evolution of vocabulary, and use of colloquialism affect the way we see ourselves and build our sense of belonging and how we differentiate ourselves from others. Attention will be given to the lived experience of communities and minority language groups.

Cohesion 1: Hate & Conspiracy Online

This breakout session further investigates issues raised during Plenary 3 around hate, prejudice, and conspiracy online. A key focus would be on conspiracy theories. It will address practical and real world solutions and practices in this regard.

Breakout Session 2 (Day 3)

Faith 2: Religion, Resilience & Cohesion (Regional Perspective)

This breakout session has an interest in different faith-based strategies in building resilience against divisive, even extremist, religious narratives within communities, and how religious leaders and communities can build wider resilience beyond their tradition across societies. It will focus on regional (Southeast Asian) contexts. Examples of good practice and ways of speaking into such situations may be discussed.

Identity 2: Diversity & Intersections (Public Policy & Common Space)

This breakout session discusses public policies across the world that have helped identify and safeguard vulnerable individuals and communities from radicalisation, and how common spaces have been found to build resilience against divisive, extremist and religious narratives in communities.

Cohesion 2: Connectivity & Connectedness

This breakout session examines good practices and case studies about people who have used online platforms to build connections between different groups of people and strengthen social cohesion. The session will also be used to understand what social media companies have been doing to promote social cohesion.

Breakout Session 3 (Day 3)

Faith 3: Faith Overcoming COVID-19 Pandemic

This breakout session explores how traditions have evolved over this challenging global Covid-19 pandemic in relation to practice rituals and ways to worship. In particular, the session discusses how communities have built internal connections within themselves despite being unable to meet physically, but also how they have utilised technology to reach out beyond their own communities.

Identity 3: Religion & Social Justice

This breakout session discusses some of the ways that religious identities inform social justice work, which in turn helps to deepen connections across various groups in society and promoting socially cohesive bonds. Areas explored may include overcoming racial and ethnic prejudice, protecting vulnerable individuals and communities beset by a lack of environmental justice, and countering radical and extremist narratives. It will seek to demonstrate examples of good practice and provide practical steps for working towards social justice from within various religious worldviews and identities.

Cohesion 3: Youth Work Initiatives


This breakout session looks explicitly at the work of youth leaders in social cohesion across Asia. The way that specific approaches to connect with young people and bridge potentially divisive partitions between communities will be of particular interest. It will stress the practice of building effective youth dialogue and service movements, rather than the theories involved in reaching younger people.

Community Showcase & Collaboration Whitespace (Day 1)



A session to encourage youth civic activism and collaboration through facilitated gameplay and an interactive showcase of ground-up initiatives by young community leaders.

Fireside Chat – Social Media for Social Cohesion (Day 2)



Hear from and engage with Reverend Chris Lee, Father Fiel Pareja and fashion designer Yasmin Jay as they share how they use their online platforms to foster interfaith understanding and respect.

Faith for Sustainability



In this session, local advocates from the faith communities such as Dr N Varaprasad, President, Hindu Centre and Teo Heng Xuan, co-founder of Dhamma Assembly for Young Working Adults, will share how faith-based organisations can drive sustainable development beyond their own communities. Participants will discuss and discover how to put intention into action and grow communities of different faiths to commit to sensitive and sustainable service.


Faith in Workplaces

Opening Address

Mdm Halimah Yacob
President of the Republic of Singapore



Mdm Halimah Yacob began her career in 1978 as a legal officer with the National Trades Union Congress. She rose through the ranks to be the Executive Secretary of the United Workers of Electronics and the Director of the Women's Development Secretariat. She was also appointed its Deputy Secretary-General in 2007 for four years.

In 1999, Mdm Halimah became the first Singaporean to be elected to the Geneva-based International Labour Organisation and served for four terms. She was elected as a Member of Parliament (MP) in 2001 for Jurong Group Representation Constituency (GRC). Her final and fourth term as a MP was in the newly formed Marsiling-Yew Tee GRC. In 2011, she was appointed Minister of State for then Ministry of Community Development, Youth and Sports, now known as the Ministry of Social and Family Development.

In 2013, Mdm Halimah was appointed as the ninth Speaker of Parliament and was the first woman to hold the position. Mdm Halimah is active in social causes and is Patron to more than 40 charitable and community organisations. She was sworn in as the eighth President of the Republic of Singapore on 14 September 2017.

Special Address

Cardinal Pietro Parolin
Secretary of State, Holy See



On 31 August 2013 Pope Francis appointed him Secretary of State and he entered into office on 15 October. Created and proclaimed Cardinal by Pope Francis in the consistory of 22 February 2014, of the Title of Santi Simone e Giuda Taddeo a Torre Angela (Sts. Simon and Jude Thaddeus at Torre Angela).

On 26 June 2018, with Rescriptum ex Audentia Ss.mi, the Holy Father Francis decided to co-opt Cardinal Pietro Parolin in the Order of Bishops, equating him in all respects to the Cardinals who were given the Title of a suburbicarian Church.

Particularly expert in matters concerning the Middle East, and more generally in those regarding the geo-political situation of the Asian continent, he has worked specifically to build up and reinforce relations between the Holy See and Vietnam. He also contributed to reopening dialogue between Israelis and Palestinians, convinced of the need for a shared effort to "create the conditions for a true and just peace" in the Middle East.

Mr Lawrence Wong is also a Member of Parliament for Marsiling-Yew Tee GRC. He co-chairs the Multi-Ministry Taskforce on COVID-19, and is the Deputy Chairman of the Monetary Authority of Singapore. He is also a member of the Government of Singapore Investment Corporation (GIC) Board, the Future Economy Council, the Research, Innovation and Enterprise Council and the National Research Foundation Board, and co-chairs the Singapore-Shanghai Comprehensive Cooperation Council.

Mr Wong was elected a Member of Parliament in May 2011 and was re-elected in September 2015 and July 2020. He has held positions in the Ministry of Defence, the Ministry of Communications and Information, the Ministry of Culture, Community and Youth, the Ministry of National Development, and the Ministry of Education.

He contributes to the labour movement as Chairman of the Singapore Labour Foundation as well as Advisor to the Union of Power and Gas Employees.

Ambassador Ong Keng Yong is concurrently Ambassador-at-Large at the Singapore Ministry of Foreign Affairs, non-resident High Commissioner to Pakistan and non-resident Ambassador to Iran. Mr Ong also serves as Chairman of the Singapore International Foundation (SIF). Mr Ong was High Commissioner of Singapore to Malaysia from July 2011 to October 2014. He served as Secretary-General of ASEAN (Association of Southeast Asian Nations), based in Jakarta, Indonesia, for five years from January 2003.

He was Singapore's High Commissioner to India and concurrently Ambassador to Nepal from 1996 to 1998. From September 1998 to December 2002, he was Press Secretary to the then Prime Minister of Singapore, Mr Goh Chok Tong. From 2008 to 2011, he served as Director of the Institute of Policy Studies (IPS) in the Lee Kuan Yew School of Public Policy at the National University of Singapore.

Closing Address

Mr Edwin Tong
Minister for Culture, Community and Youth and Second Minister for Law, Republic of Singapore



Mr Edwin Tong SC was appointed Minister for Culture, Community and Youth and Second Minister for Law on 27 July 2020. Prior to this, he served as the Senior Minister of State at the Ministry of Law and the Ministry of Health from 1 July 2018 to 26 July 2020.

As the Minister for Culture, Community and Youth, Mr Tong chairs the National Integration Council, the Singapore Cares Steering Committee, the National Youth Council, and the National Steering Committee on Racial and Religious Harmony, driving efforts to build a caring, cohesive and confident society in Singapore. Since November 2020, he also chairs the Chinese Community Liaison Group, which was set up to strengthen Government's relationship with Chinese community organisations and deepen the Government's understanding of the Chinese community.

At the Ministry of Law, he focuses on the development and promotion of Singapore's legal and dispute resolution sector. He also handles wide-ranging aspects of law reform, including intellectual property, corporate restructuring and insolvency, and legal aid.

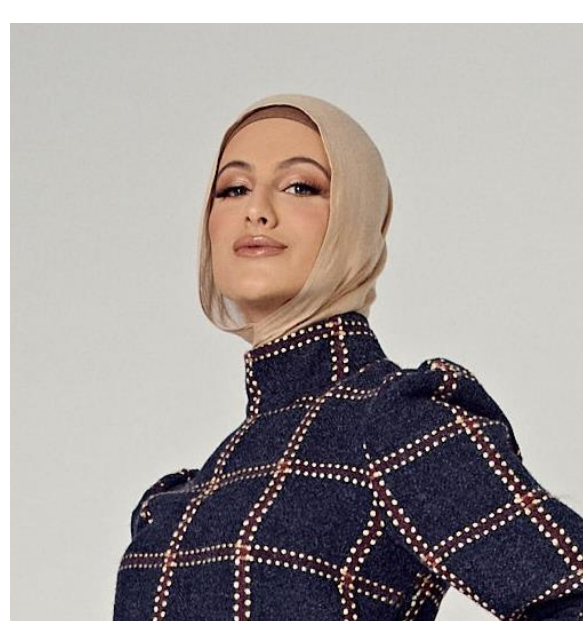

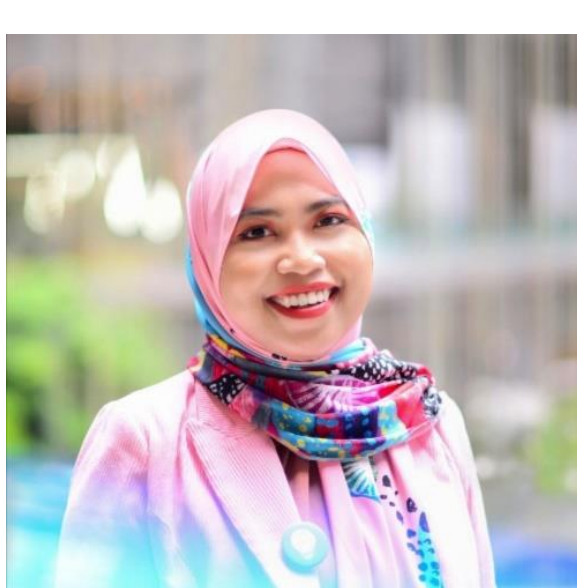
Dr Tan Lai Yong
